THIS INDENTURE, made this 10th day of November A.D.1922, between BARTLESVILLE ZINC COMPANY, a Corporation duly created and existing under the laws of the State of New York, hereinafter called the Bartlesville Company, party of the first part, and BLACKWELL ZINC COMPANY, INC. a corporation duly created and existing under the laws of the State of New York, hereinafter called the Blackwell Company, party of the second part, WITNESSETH:

That the Bartlesville Company, in consideration of Ten Dollars, and other good and valuable considerations, the receipt and the sufficiency whereof are hereby acknowledged, does by these presents grant, bargain, sell and convey unto the Blackwell Company, its successors and assigns, all the following described real estate situate in the County of Kay and State of Oklahoma to-wit:

The Northeast Quarter of Section Twenty-One,
Township Twenty Seven North, Range One West,
containing One Hundred and Sixty acres of land

more or less, subject only to the right of way of the Atchison, Topeka and Santa Fe Railway Company through, over and across the same, and to the certain permit or license, granted October 30, 1918, by the Bartlesville Company to Theodore E. Kaufold, and Mary J. Kaufold, his wife, to drill for oil and gas in Ten acres in the Southeast corner of said Northeast Quarter, reference to which said permit or license is hereby made for greater particularity.

The Northwest Quarter of Section Twenty One -
in Township Twenty Seven North, Range One West
containing One Hundred and Sixty acres of land
more or less,

subject only to the right of way of the Atchison, Topeka and Santa Fe Railway Company through over and across the same, and to the certain lease for five years made by the Bartlesville Company, on March 5, 1921, to the Tower Gasoline Company of One acre in the Northeast corner of said Northwest Quarter, reference to which said lease is hereby made for greater certainty.

The Southwest Quarter of Section Twenty One,
in Township Twenty Seven North, Range One West,

TO HAVE AND TO HOLD THE SAME, together with all and singular the tenements,

hereditaments and appurtenances thereunto belonging or in anywise appertaining forever.

And the Bartlesville Company for itself, its successors and assigns, does hereby covenant, promise and agree to and with the Blackwell Company, that at the delivery of these presents it is lawfully seized in its own right of an absolute and indefeasible estate of inheritance, in fee simple, of and in all and singular the above granted and described premises, with the appurtenances; that the same are free, clear, discharged, and unincumbered of and from all former and other grants, titles, charges, estates, judgments, taxes, assessments and incumbrances, of what nature and kind soever, save and except as hereinbefore specifically mentioned, and that it will warrant and forever defend the same unto the Blackwell Company, its successors and assigns, and all and every person or persons whomsoever, lawfully claiming or to claim the same.
