KAY CO. GRAND JURY SUBMISSION OF QUESTION

I, <u>Jessica Pepper</u>, formally request the Kay Co. Grand Jury to consider the following question for review.

Did the City of Blackwell violate State Law by using the Executive Session clause of the Oklahoma Open Meeting Act in connection with the engagement of legal counsel for the City of Blackwell, and/or the termination of a contract for an engineer?

Oklahoma statue Title 25 Chapter 8 Section 307 states, "...No body shall hold executive sessions unless otherwise specifically provided in this section... Executive session of a public body will be permitted only for the purpose of: 1. Discussing the *employment*, *hiring*, appointment, promotion, demotion, disciplining or resignation of any <u>individual salaried</u> public officer or employee." (Emphasis Added)

The Attorney General's Opinion 2005 OK AG 29, in paragraph 13 states "... 1. A public body may hold an executive session under the Open Meeting Act only to discuss the 'employment, hiring, appointment, promotion, demotion, disciplining or resignation of any individual salaried public officer or employee[.]' 25 O.S. Supp. 2004, § 307 (B)(1). Discussing awarding a contract for professional services when the recipient will be an <u>independent contractor</u>, rather than a public officer of the public body, is not a proper subject for an executive session. Whether a particular position qualifies as an employee or an independent contractor is a question of fact outside the scope of an Attorney General Opinion 74 O.S. 2001, § 18b (A)(5).

The minutes from the City's meeting of February 28, 2007, cite "... 2. Discussion and Possible Action regarding the Legal Avenues and Strategies of Finalize Settlement Agreement with Phelps Dodge, *Including the Possible Hiring of Additional Counsel and/or Experts* and Possible Authorization for Litigation." (Emphasis Added).

At the beginning of another special joint meeting of the Board of Commissioners/BMA, and the BIA on March 27, 2007 Brad Bechtel (City Commissioner Ward 4/Trustee) motion to hire Don Shandy as special counsel to represent Blackwell in negotiations and settlement with Phelps-Dodge and ODEQ. The motion carried.

In the time frame between the two meetings, there were no other discussions about contracting with Don Shandy for his legal counsel. It is evident that the decision to hire Don Shandy occurred during the meeting of February 28, 2007 with no public discussion.

September 18, 2006 during a City Commissioner Meeting, the commissioners went into executive session to discuss Jim Willis' request for his engineering contract to be terminated. Jim Willis was a contracted engineer for the City of Blackwell since the year 2000. From 8:30pm to 9:15pm the Commissioner discussed the termination of his contract and then approved the termination before the public. No discussion about his engineering contract was discussed during open session.
