## ORDINANCE

State of Oklahoma, Kay County, ss. Filed for record Mar. 16, 1916, at 2:10 P.M. C. S. Ford, County Clerk, By O. E. Hodges, Deputy.

ORDINANCE NO. 583

An Ordinance extending the corporate limits of the City of Blackwell, Kay County, Oklahoma so as to include all of the

North east Quarter of Section twenty-one, township twenty-seven, North Range one, West, except the Atchinson, Topeka and Sante Fe Railway right of way, containing one hundred and sixty acres more or less.

Be it Ordained by the Mayor and Councilmen of the City of Blackwell, Oklahoma. Section one;

That the Mayor and Councilmen of the City of Blackwell find that the northeast quarter of section twenty one in township twenty seven, north, Range one, West, less the Atchinson, Topeka and Sante Fe railway right of way, containing one hundred and sixty acres more or less, is immediately adjoining the corporate limits of the City of Blackwell and that it is necessary that the corporate limits be extended so as to include said tract of land. Section two;

That the Mayor and Councilmen of the City of Blackwell find a petition has been filed with the City Clerk by Theodore E. Kaufold, being the sole and only legal voter residing upon said land and that a consent to the annexation of said tract to said city has been filed with the City Clerk by Theodore E. Kaufold and Mary J. Kaufold, his wife, they being the sole owners of said above described tract of land.

Section three;

That the corporate limits of the ofty of Blackwell be and are hereby extended so as to include in its corporate limits all of

The northeast quarter of Section twenty-one in Township twenty-seven, North, Range One, West, less the Atchinson, Topeka and Sante Te Railway right of way, containing one hundred and sixty acres more or less;

said tract of land to be exempt from city taxes under Section 500 of the Revised laws of 1910 of Oklahoma, so long as same remains in a tract or tracts in excess of (40) forty acres. Section four;

That immediately upon the passage, approval and publication of this Ordinance in the Times-Record the official paper of the city of Blackwell, the City Clerk shall furnish to the County Clerk of Kay County, Oklahoma a copy of said Ordinance with an accurate map of the territory annexed, duly certified by the Mayor, the copy of the same to be recorded in a book kept for that purpose.

Section five;

For the preservation of the peace, health and safety of said city, an emergency is hereby declared to exist whereby this Ordinance shall take effect and be in full force from and after its passage, approval and publication.

OIL AND GAS MINING LEASE BY GUARDIAN, UNDER ORDER OF COURT.
